UPDATE on DEATH PENALTY

At the January meeting John Williams updated the Group on key aspects of the DP. NB this refers to official state positions and does not cover extrajudicial killings.

Abolition Chronology: The first country to abolish the DP was Venezuela in 1863, and the most recent Kazakhstan in January 2021. Since 1985 there have only been 8 years when no country has abolished the DP.

Africa: Egypt is the biggest executor. Other countries using the DP are Botswana, Equatorial Guinea, Libya, South Sudan and Nigeria.

Caribbean: Dominic Republic and Haiti have abolished the DP; the rest have it *de jure* (i.e., in law but not in action). The last executions were in Saint Kits and Nevis in 2008. **Central & South America:** The DP exists in Belize & Guyana although it has not been used for years. In Brazil, Chile, El Salvador, Guatemala and Peru the DP is only legal in exceptional/special circumstances.

Asia: Most executions worldwide take place in Asia. China executes more people for more reasons than the rest of the world combined. Iran & Saudi Arabia, also have high levels of executions. North Korea uses the DP against high-level criminals and those suspected of committing "grave offences". Bangladesh, Iraq, Pakistan, Syria, Vietnam and Yemen all use the DP. India executes in extreme cases.

Of the 12 countries with a "very high" Human Development Index" which practice the DP, 10 are in Asia: Japan, Taiwan, Singapore, Oman, Qatar, and United Arab Emirates.

Europe: The European Union holds a strong position on the DP, abolition is a precondition for entry. Belarus is the only European country using the DP. Russia has a moratorium and last used the DP in 1999.

Oceania: Nearly all countries have abolished the DP. Papua New Guinea and Tonga still have it in law, but not used it in decades. The last known executions took place in 1982. **USA:** Colorado became the 22nd state to abolish the DP. 2020 saw the fewest new DP sentences in the modern era with state executions the lowest in 37 years.

Race continues to play a significant role in the use of the DP.

Trump agreed more federal executions than all the states combined.

DETERIORATING HUMAN RIGHTS IN CHINA

In a sign that the human rights situation in China is extremely severe, between 8th and 22nd January Amnesty International issued no fewer than 5 Urgent Actions. These highlighted the range of means whereby the Chinese authorities are seeking to suppress all dissent.

- The National Security Law of June 2020 being used in Hong Kong is so broadly worded that it undermines the human rights protection of detainees. UN Human Rights sources say that national security cannot be used to suppress the right to express political views.
- Criticism of China by family members overseas is leading to the arrest of individuals such as Gulshan Abbas, a retired doctor whose sister spoke out in the United States about the Uyghurs. Gulshan was accused of being a "separatist", taking part in terrorism and sentenced to 20 years in prison after a secret trial.
- Sensitivity about COVID-19 is extreme, and journalists who report on it risk jail sentences of 4 years.
- Thousands of Uyghurs and other minorities are detained in centres which the Chinese authorities claim are for education and training, but in reality aim to destroy minority ways and culture through brainwashing, forced labour and torture.
- Families of detainees are not kept informed about charges, trials, welfare or access to legal support of their choosing. One U.A tells of a Kazakh family who were taken to an "education centre", and only heard unofficially that the father had died in custody.
- Torture is widespread. A journalist gave up her hunger strike to avoid having her legs shackled and her hands restrained, and there is grave concern for her ongoing welfare. Deprivation of health care is used as a punishment.

AIUK has a new China Country Coordinator who is enthusiastic and imaginative, and is organising campaign meetings through Microsoft Teams which anyone can join. Some of the actions she sends out will be forwarded to Southampton Group members, so please support Amnesty's China campaigning. There is so much to do!

Dear Minister Pazuello,

I am writing to express my concern regarding the current situation in the hospitals of Maneus. I understand that there are more than 1500 people hospitalised with COVID-19 in the city and thousands more infected. With this spike in infections, the hospitals are at maximum capacity but there is a critical lack of oxygen to treat patients currently hospitalised. I understand that the federal government has now sent oxygen tanks to the city. But this supply is insufficient to meet current demand. Other cities and states in nearby regions could also be at risk of facing a similar situation.

I call upon you to take all the necessary steps to guarantee the right to health of patients in the city of Manaus and other cities in nearby regions that could face similar risks, by ensuring that they are equipped with an adequate supply of oxygen and other urgent medical supplies, and by using maximum available resources to ensure that proper treatment is provided based on international scientific standards.

SOUTHAMPTON AMNESTY FEATURED FROM AUSTRALIA

One of our Group's old friends, Jay Turner, has mentioned us (and Fran in particular) in concerts streamed from his home in Australia. Jay was one of the headline acts in "Folk for Freedom", which we ran in Southampton from 1991 to 2000. A heady mix of music, campaigning, curry and chilli. They developed from a one-off concert into the centrepiece of a weekend human rights arts festival-only stopping when our main venue, The Gantry, was demolished!

Jay and his wife Cath also performed their last concert before moving to Australia in 2005 in aid of our Group. They should have been touring in the UK recently, but due to COVID restrictions instead performed a "Not the UK tour" virtually from their own home. In addition to describing involvement with Southampton Amnesty, they perform "Writing for Freedom", a song inspired by Amnesty's Write for Rights Campaign and which Jay released in aid of Amnesty at the time.
