Annual General Meeting July 2021

Summary of GROUP ACTIVITIES 2020-2021:

Despite the difficulties posed by the pandemic the Group has held meetings every month online and has endeavoured to keep all members and supporters involved through the Newsletter and campaign actions.

In September we met up with members of the Romsey Group and enjoyed a historic walk round Eling and a picnic lunch.

Guest speakers at our virtual meetings have included: the AI Country Coordinators for Russia and Eritrea, the Project Manager of Clear, who spoke about the difficulties faced by people seeking refuge in the UK. Simon John who spoke about modern slavery. In March we joined the Romsey Group for a joint session, the speaker was Caroline Nokes MP, who presented a critique of the Governments approach to immigration.

There have been several projects to "spread the word". Two of the Write for Rights cases featured in the Phoenix Film Society's Christmas Newsletter, and the photo mosaic of Marielle Franco has now been deposited in the Sea City Museum, the Hampshire Archives and the Wessex Film and Sound Archives as one of their Covid-19 stories.

To celebrate the 60th anniversary of the founding of Amnesty, the group produced a short video on YouTube. The link was sent to local MPs and councillors. It triggered a radio interview and an article in the free magazine "Discover".

In addition to work on our regular cases, we also took action for Idris Khattack (Pakistan), women from Saudi Arabia, Uyghur children separated from their parents, and Nazanin Zagari-Ratcliffe.

Gareth attended the virtual AIUK AGM. He outlined interesting arguments from proposers of 2 motions, which we had discussed within our Group (one on China, and one on the relationship between the International Secretariate and National Sections of Amnesty).

However, he felt the AGM needs improvement for future years, whether it is online-only or simply online-accessible. Discussion appeared to be dominated by campaigners on narrow, and often internally focused issues. Quite possibly the online nature made it less appealing to people who have a more expansive approach to human rights. A particular difficulty arose from the way the AGM was organised. There were no amendments (which often "soften" motions) allowed, and no arguments against motions being provided in advance (except for one motion which the Board opposed). Around three-quarters of votes (including our Group's votes) were cast in advance of the meeting, without hearing any of the contrary arguments. Potentially as a consequence, all 14 motions were passed!

THE "DISAPPEARED of ERITREA 20yrs on

In 2001 the Eritrean Government closed all independent media and carried out mass arrests of journalists and politicians including **DAWIT ISAAK** and **ASTER FISSEHATASION**. It is not known whether any have survived 20 years in the horrific prisons of Eritrea

Your Excellency,

September 18th will mark the twentieth anniversary of the closure of all non-Government media in Eritrea following which the most distinguished of the journalists were arrested. On that same day, the politicians who had been seeking more democracy were arrested and "disappeared". During these twenty years, no information has been given to any court or been released to any family members of the "disappeared".

Eritrea was a proud signatory of The Universal Declaration of Human Rights and I wish to emphasise the importance of the following Articles from that Declaration:

"Article 9 No one shall be subjected to arbitrary arrest, detention or exile.

Article 10 Everyone is entitled in full equality to a fair and public hearing by an independent and impartial tribunal, in the determination of his rights and obligations and of any criminal charge against him.

Article 11 1 Everyone charged with a penal offence has the right to be presumed innocent until proved guilty according to law in a public trial at which he has had all guarantees necessary for his defence."
