A REVIEW OF OUR CAMPAIGNING STRATEGY

The six core members of the Southampton Group met recently to consider ways to improve our impact and visibility locally in the hope of recruiting new (and younger!) members. We are proposing to do this by reviewing and reducing the number of areas we work on within Amnesty, and to focus specifically on a few where we feel we might make progress.

We will continue to invite speakers to our monthly meetings from a wide range of areas as before, so that we remain a Group that is well informed and concerned about Human Rights abuses.

ERITREA

One of the key areas we have decided to focus on is Eritrea. We will endeavour to highlight a specific area of human rights concern each month. As a way of introducing the Eritrean human rights concerns, the first paragraph of Amnesty International 2019 report is quoted below:

"The use of indefinite military conscription, amounting to forced labour, has continued despite an agreement to end the protracted border dispute with Ethiopia, a dispute the government had used to justify prolonged national military service. Thousands were prevented from travelling abroad without government permission, or due to repeated border closures. Arbitrary detention and enforced disappearences continued. Security forces restricted the right to freedom of expression inside the country, and government supporters attacked and threatened human rights defenders in the diaspora."

The report goes on to highlight several key human rights areas:

- Refugees and asylum seekers
- > Freedom of movement
- > Forced labour and slavery
- Arbitrary arrests and forced disappearences
- Freedom from expression

Each of these areas will be discussed in more detail in future Newsletters.

One of the six core members, Mary Brown, who has worked on Eritrean cases in the past has identified a number of ways we may campaign on Eritrean issues. These include:

- Lobbying local MPs
- > Approaching the All-Party Group on Eritrea
- ➤ Building on the support of local Councillors
- Our Group also has an excellent relationship with Alex Jackson, Amnesty UK Country Coordinator for Eritrea.

There are currently three specific cases of concern in Eritrea as well as the broad Human Rights issues.

- Aster Fissehatsion, a "disappeared" politician. Aster Fissehatsion has been held incommunicado without charge or trial since 18th September 2001. She is a Prisoner of Conscience.
- Dawat Isaak, a "disappeared" writer and journalist.
- ➤ Ciham Ali Ahmed, US Eritrean national. Details of how to campaign on Ciham's case are on next page.

CIHAM ALI AHMED

US-Eritrean national held for nine years

Born in Los Angeles and raised in Eritrea, a fan of Lady Gaga and Green Day, Ciham Ali Ahmed wanted to become a fashion designer. But at the age of 15 her hopes were shattered. On 8 December 2012, Ciham was arrested at the Sudanese border as she tried to flee Eritrea. Nine years on, her family do not know where she is being held. Ciham has not been charged or brought to trial. It is as if she has vanished.

Prior to her arrest, Ciham's father Ali Abdu, then minister of information under President Isaias Afwerki, went into exile just as the military attempted a coup against the government. It was rumoured Ali Abdu had supported the coup and Ciham may have been arrested in retaliation.

Eritrea is notorious for imprisoning people in underground containers. Many detainees have died from torture, starvation, infection and other appalling treatment.

Although she's a US citizen.. Ciham has been ignored by the US government. It has stayed silent on her plight, even though it has the power to influence Eritrea.

"You have just taken a child who has child-like dreams. You are basically saying I will punish you and detain you, and you'll spend half of your life in prison."
